The Gambler by Thomas C. Schleifer PhD

Why do so many construction companies fail without anyone realizing they were about to go under? When I ran the largest surety consultancy in the country that completed projects for bonding companies after construction firms had suddenly failed, I was amazed to discover that the majority of those contractors were completely surprised that they had failed. And they rarely knew why they had failed.

Place Your Bets

Construction contracting is unlike any other business. The product is sold for a future fixed price before anyone knows exactly what it will cost to build. If you think about it, this is a novel way to do business. In effect, we contractors are placing a bet that we will get paid a sufficient pre-arranged amount after incurring costs we can only tally after the job is complete. In other words, contractors are gamblers. Every time we win a bid and sign a contract, we are betting that we can make a profit on the transaction.

"Know When to Hold 'em - Know When to Fold 'em"

Like the song says, the first rule of the gambler is, "You've got to know when to hold 'em and

know when to fold 'em." As gamblers this is the most vital skill contractors can develop. But how can we know when to bid a job or when to stand pat? How can we accurately estimate the total costs we will incur in a hyper-inflation environment two years into the future? How can we place an informed bet rather than play a hunch? Only suckers play hunches.

3 Profit Pitfalls in Project Accounting by Chris Milan

When we talk with construction CFOs about profit pitfalls that could lead to major profitability drains, it's clear that the key lies in accurate project-by-project accounting. It's essential to maintaining control of your overall budget and resources, generating timely and accurate billing and establishing each project's profitability.

But while project-based industries, like construction, rely on project accounting for accurate estimating, time and resource management, billing and more, many construction businesses aren't using project accounting software to help manage their projects.

Consider these statistics:

- 34% of projects have no baseline (Wellington)
 - 27% of all IT projects go over budget (HBR)
- Businesses see "capturing time/costs against projects" as their biggest challenge in project management (Capterra)
 - 60% of small and medium businesses (SMBs) use manual methods for project management, non-project management software or nothing at all to manage projects (Software Advice)
 - 52% of projects experience scope creep (Project Management Institute)

988 has been designated as the new three-digit dialing code that will route callers to the National Suicide Prevention Lifeline. CFMA National Education Update from Joe Harper

Microlearning

We have introduced the importance and power of microlearning, or nano learning to the Greater Cincinnati Chapter of the CFMA in the past. National is working very hard to launch this product. The exciting news is, not only is the CFMA Microlearning Task Force going to preview the first content in this effort in July (Cash Flow and Forecasting), but we are in conversations in creating two avenues to deliver microlearning content. The Birthplace of American Astronomy

The Cincinnati Observatory is known as 'The Birthplace of American Astronomy.' It houses one of the oldest working telescopes in the world and was the first public observatory in the western hemisphere. Recently restored to its original beauty, the Observatory is a fully functioning 19th century observatory used daily by the public and amateur astronomers. The main telescopes are an 11-inch Merz and Mahler refractor from 1845 and a 16-inch Alvan Clark and Sons refractor from 1904. The historic buildings are designated as a National Historic Landmark, and the grounds provide a serene, park-like setting while still being centrally located in the city of Cincinnati.

The old telescope in Cincinnati has always been the people's telescope. In 1842, Cincinnati professor Ormsby MacKnight Mitchel was a dynamic, eloquent speaker and the first American populizer of astronomy – the Carl Sagan of the 1800s. Mitchel began raising money for the telescope and the observatory building. He went door to door soliciting \$25

per person to invest in this new endeavor (that was the equivalent to an average monthly salary in 1842). Contributions came from all walks of life and every trade. In one month and a half, Mitchel raised nearly \$7,500 – enough to start shopping around for a proper telescope in England and Europe. Finally in Munich, Bavaria (prior to a unified Germany) he discovered an 11-inch lens of incomparable quality that had already been ground but never installed. The tube was then constructed of brass and mahogany and the completed telescope was shipped via New Orleans, up the Mississippi and Ohio Rivers to downtown Cincinnati.
