Hey CFMA just launched. Check it out!!!

"Hey CFMA" is CFMA's informal microlearning platform. The purpose of informal microlearning is not the CPE, but rather to fill in a knowledge gap quickly and efficiently. "Hey CFMA" is our answer to Google for the unique areas of construction finance. For example, if a newer controller wants to understand an overview of how a surety looks at their financial statement before discussing that issue at a board meeting, they can type "bonding" in "Hey CFMA", and the bonding specific videos in the CFMA's library will appear. Each video is typically a 3-5 minute snapshot of wisdom on a construction finance related topic (one learning objective for each video) presented by our members. The user can choose which videos to watch to answer their immediate question/s. Within 15 minutes, they are better able to have a conversation with their company's leadership about bonding.

Winter 2023 accounting standards update 01/16/2023 STEPHANIE ALLGEYER

At this time of year, it is important to familiarize ourselves with the Accounting Standards Updates (ASUs) that are now effective for the first time, along with a few that may be coming down the pipeline. Included is a sample of the most prevalent standards for non-public business entities (which have different effective dates).

Effective during calendar year 2022

ASU 2016-02: Leases (Topic 842): Leases

Overview: Lease commitments in various forms must be included as part of the balance sheet and will be recorded as a right of use asset with a corresponding liability and amortized of the life of the leases.

Implementation: Effective for years beginning after December 15, 2021. ASU 2016-02 Leases should be implemented and reviewed in conjunction with the numerous amendments and practical expedients.

What Is Mindfulness?

Although the definition of mindfulness varies, I like to reference Jon Kabat-Zinn: "Mindfulness is paying attention on purpose in the present moment non-judgmentally." He identifies three main tenets of mindfulness.

Be Present

The concept of staying present is straightforward, but implementing this practice in your daily life can be challenging. We are constantly bombarded with distractions, and our minds are easily drawn in multiple directions. Remaining present is a skill that we can grow through mindfulness practices and one that ultimately improves our ability to focus, reduces spiraling thoughts, and allows us to enjoy each moment.

Awareness

Mindfulness teaches us to be aware of our bodies and emotions; we slow down when we practice and notice feelings or thoughts. Building this skill translates directly into how we treat ourselves and others. We learn how to extend more compassion and empathy with ourselves and ultimately to those around us. We are also better able to pause before we react to a situation, examine and understand our initial inclinations, and determine how we want to move forward rather than simply reacting.

The Ingalls Building, built in 1903 in Cincinnati, Ohio, is the world's first reinforced concrete skyscraper. The 16-story building was designed by the Cincinnati architectural firm Elzner & Anderson and was named for its primary financial investor, Melville E. Ingalls. The building was considered a daring engineering feat at the time, but its success contributed to the acceptance of concrete construction in high-rise buildings in the United States. It was converted to a hotel, the Courtyard by Marriott Cincinnati Downtown, in 2021.[1] The Ingalls building is bordered by East 4th Street and Vine Street in the Cincinnati Central Business District.
