

New accounting lease standard refresher (spring 2022)

In June 2020, when the Financial Accounting Standards Board (FASB) extended the compliance deadline for private companies and nonprofit organizations by releasing Accounting Standards Update (ASU) 2020-05, Leases (Topic 842), most of the private accounting world rejoiced. Unfortunately, it appears there will be no further extensions

on the implementation of this standard. Additionally, you must implement for years beginning after December 15, 2021.

This article will provide a refresher on the standard, point you in the direction of creating an implementation guide for your business, and provide some additional advice on communication with the users of your financial statements.

Losantiville County Club is the third oldest country club in Cincinnati.

It was founded in 1902 making the club over a century old. The leading golf architect was Tom Bendelow. He was a prolific golf architect who was known as the Johnny Appleseed of American Golf. He laid out more than 800 courses in his lifetime. He used just brooms sticks and a blueprint to lay out the final course of Losantiville that we see today.
